CONSIDER MINUTES OF THE NOVEMBER 7,2023 REGULAR SESSION.

Motion was made by Council Member Dale, Second by Council Member Adams to Approve of Minutes of the November 7,2023 Regular Session. Upon a vote, the motion carried unanimously.

PRESENTATION OF THE UTILITY RATE STUDY AND CONSIDER APPROVAL OF ORDINANCE 2023-27 AMENDING THE CITY'S WATER AND SEWER RATES

Case No. A-2023-01. Upon a vote, motion carried unanimously.

JONES SURVEY, ABSTRACT NO. 307, TITUS COUNTY, TEXAS, AND IN THE CITY OF MOUNT PLEASANT, AND BEING IDENTIFIED AS LOT 5 & PT 4B (2.568-ACRES), BLOCK 349, MT. PLEASANT CITY BLOCKS, AND LOT 6 (5.8224-ACRES), BLOCK 349, MT. Pleasant City Blocks, Titus County, Texas, City of Mount Pleasant, Texas and generally located at the northwest corner of the intersection of E. Ferguson Road [TX-49] and Choctaw Street. PP-2023-01. Upon a vote, the motion carried unanimously.

<u>DISCUSSION AND CONSIDER APPROVAL OF PROPOSAL FROM TITUS COUNTY ON COUNTY/CITY FIRE</u> CONTRACT.

Motion was made by Council Member Dale, Second by Council Member Adams to Approve of Proposal of a 10 year contract beginning 10/1/2024 for \$980,000.00 with a 3.5% increase annually starting year 2, no capital purchases and a 3 minute clause. Upon a vote, motion carried unanimously.
