Motion was made by Council Member Spruill, Second by Council Member Hageman to Appoint Greg Nyhoff as the Interim City Manager effective Wednesday, May 29, 2024, with noted exceptions to advertising the position as provided under the city handbook, and to the residency requirement under the City Charter given the urgent need to fill the position on an interim basis with a contract negotiated by Council Member Hageman in accordance with the terms discussed in executive session to be brought back to council for approval. Upon a vote, motion carried unanimously.
